- 7. Only individuals employed in New Zealand can be nominated.
- 8. Nominations may be made for the following awards:

  - b. Equine Licence Holder Excellence;
  - c. Greyhound Excellence;
  - d. Dedication to Breeding Excellence;
  - e. Stud, Stable & Kennel Excellence;
  - f. Administration & Innovation Excellence;
  - g. Care and Welfare Excellence;
  - h. Newcomer Excellence; and
  - National Racing Woman of the Year.

### Awards

- 9. There will also be an overall winner selected from the winner of all categories.
- 10. Further details about the Awards, including judging criteria and prize money, will be published on the Awards website (entaingroup.co.nz/industryawards)
- 11. An individual may be nominated for multiple awards, but a separate nomination form must be completed for each category.
- 12. Entain NZ reserves the right to reject any nominations.
- 13. Nominators agree to be contacted by Entain NZ to verify any information regarding their nomination.
- 14. Referees/nominators provided in award entries may be contacted by Entain NZ, but Entain NZ is not obliged to do so.
- 15. Award category winners at the 2024 Awards are ineligible to be nominated for the 2025 awards.

## **Judges & Selection of Winners**

- 19. Each Finalist must be available to attend the Award Ceremony to be held on Sunday 29 June 2025 ("Ceremony"). The Venue will be selected and confirmed by Entain NZ in their sole discretion, and will be communicated once determined. Should a Finalist be unable to attend the Ceremony, the Judges reserve the right to select another Finalist at their discretion.

#### **Finalist**

- d. Airport transfer to accommodation.

- 24.
