

ENTAIN NZ INDUSTRY EXCELLENCE AWARDS – TERMS AND CONDITIONS

1. All Entrants (“**Entrants**”) who participate in the Entain NZ Industry Excellence Awards (the “**Competition**”) are deemed to accept these terms and conditions of entry. Any entries in this Competition that do not comply with these terms and conditions will be deemed invalid and Entain New Zealand Limited (“**Entain NZ**”) takes no responsibility for such entries. All times given in these terms and conditions are references to New Zealand Local Time and all references to currency are referring to New Zealand Dollars.

Nomination period

2. The period for nominations opens 27 May 2024 and closes at 5pm on Sunday, 23 June 2024 (“**Nomination Period**”).

Nomination Process

3. Nominees must work in the New Zealand Thoroughbred, Greyhound or Harness Industry.
4. All nominees must have consented to be nominated.
5. All nominations must be submitted by sending the required Nomination information as stated on the Awards Website to industryawards@entaingroup.co.nz. Nominations submitted incorrectly will not be considered.
6. Only individuals employed in New Zealand can be nominated.
7. Nominations may be made for the following awards:
 - a. Leadership Award;
 - b. Equine Handling Award (Stud or Stable)
 - c. The Greyhound Excellence Award
 - d. Dedication to Breeding Award
 - e. Dedicated to Racing Award
 - f. Administrative and Ancillary Services Award
 - g. Care and Welfare Award
 - h. Newcomer Award (Stud or Stable)
 - i. Entain Excellence Award
 - j. National Racing Woman of the Year

(“**Awards**”)

8. There will also be an overall winner selected from the winner of all categories.
9. Further details about the Awards, including judging criteria and prize money, will be published on the Awards website.
10. An individual may be nominated for multiple awards, but a separate nomination form must be completed for each category.
11. Entain NZ reserves the right to reject any nominations.
12. Nominators agree to be contacted by Entain NZ to verify any information regarding their nomination.

Judges & Selection of Winners

13. The judges of the Competition ("**Judges**") will be employees and/or contractors of Entain NZ, to be selected by Entain NZ at its sole discretion.
14. After the close of the Nomination Period, the Judges will review all accepted nominations and in their sole discretion select one winner and two runners-up for each Award ("**Finalists**").
15. Each Finalist will be contacted by Entain NZ using the information supplied in the nomination form to discuss travel arrangements and any other information Entain NZ reasonably requires.
16. Each Finalist must be available to attend the Award Ceremony to be held at the Glasshouse, Auckland on Sunday 28 July 2024 ("**Ceremony**"). Should a Finalist be unable to attend the Ceremony, the Judges reserve the right to select another Finalist at their discretion.
17. The final decision in respect of the Finalists, including the winners and runners up for each award, will be at the sole discretion of the Judges and no correspondence will be entered into.
18. Entain NZ reserves the right to amend the nomination form, impose additional requirements on nominations, change the judging criteria and make other variations to the nomination and awards process at any time.

Finalist

19. Each Finalist shall receive:
 - a. Return flights for two to and from the domestic airport, nearest the Finalist's home, to Auckland;
 - b. Tickets for two to attend the Award Ceremony
 - c. Two nights' accommodation to be selected by Entain NZ;
Airport transfer to accommodation.

("Finalist Package")

20. For the avoidance of doubt, the Finalist Package does not include any spending money or travel allowance.

21. Entain NZ is not responsible for any costs, expenses or losses incurred by the Finalist or their companion in redeeming the Finalist Package, including if the Finalist or their companion any flight, any flight is delayed, or any other event occurs which is beyond the control of Entain NZ and causes further expense to be incurred by the Finalist or their companion.

Prize

22. At the Ceremony the winner and runners-up for each Category and the overall award winner will be announced
23. The winner of each award shall win \$10,000.
24. Each of the runners-up for each award shall win \$2,000.
25. The overall award winner shall win an additional \$5,000, and an educational package worth \$5,000 to be selected & arranged by Entain NZ.
26. Entain NZ will discuss appropriate payment methods for the Prize with each Finalist after the conclusion of the Ceremony, but at its discretion may require a particular payment method to be followed.
27. All prize money will be paid subject to applicable taxes and deductions. The Prizes are not exchangeable or transferrable.
28. The decision of the Judges in determining the winners and runners up in each category is final and no correspondence will be entered into.

Additional Terms

29. All nominees agree to be involved in any reasonable promotional activities stipulated by Entain NZ (without compensation), including but not limited to the publication of the Prize Winner's name, place of residence, and any images. Entain NZ will own the copyright in any such images and photograph(s) and in all material incorporating the photograph(s) or film.
30. If this Competition cannot be run as planned for any reason, including for reasons beyond the control of Entain NZ, Entain NZ reserves the right in its sole discretion to cancel, terminate, modify or suspend this Competition (or any part of this Competition), at any time.
